## **CONSTITUTION & BYLAWS**

Updated April 2024

### **ARTICLE I - NAME OF CLUB**

The name of this 501C corporation is Coast Riders Motorcycle Club, Inc. also known as Coast-Riders, here in after referred to as "Coast Riders" or "The Club".

### **ARTICLE II - PURPOSES AND HISTORY OF THE CLUB**

#### **Section 2.01 - Purposes**

The main purpose of Coast-Riders is simple: to have fun with our motorcycles. One of the ways to do this is to participate in organized rides with others who share our interests. As we grow in size, the Club can also provide additional functions, like charity fund raising rides and hosting motorcycle shows on the Central Coast.

#### **Section 2.02 - History**

(a) The Club was formed in January of 2002. (b) Membership has grown substantially since the club was founded, and a variety of rides have been organized (c) With the expansion of membership a commitment to the Food Bank Coalition of San Luis Obispo and National Multiple Sclerosis Society was created. Through our fund raising efforts, our hope is to help them better serve the community.

### **ARTICLE III - MEMBERSHIP & ACTIVITIES**

#### **Section 3.01 - Eligibility & Dues**

Anyone is eligible to join Coast Riders. There is a suggested \$65 per year membership fee which covers costs for maintaining the Club.

#### **Section 3.02 - Place & Time**

Coast Riders meets on the last Wednesday of each month at 6:30 pm, unless otherwise noted. Meeting locations can be either The PETRA Mediterranean Pizza and Grill, 1201 Higuera St., San Luis Obispo, CA 93401 or various company tours.

#### **Section 3.03 - Release of Liability & Ride Safety Agreements**

All members and guests must agree to and sign a Release and Wavier of Liability Assumption of Risk and Indemnity Agreement to participate in any Coast-Rider ride or event.

### **ARTICLE IV - OFFICERS**

#### **Section 4.01 - Qualifications & Terms of Office**

Any member of this Association is qualified to be a Officer hereof. There are currently no term limits for officers. Positions are on a strictly volunteer basis and can change at any time, without prior notice.
